



## Wenatchee 911 Driving School Teen Policies

### **Eligibility:**

Students must be 15 years old by the first day of class.

Enrollment will not be allowed after the Third Classroom Session.

Classroom and Behind the Wheel instruction will be completed in no less than 30 days.

Classroom and Behind the Wheel instruction must be completed within 6 months.

Student must acquire Learner's Permit by 3rd day of class, or they will be dropped from class.

Teen Policies must be signed and turned in by the third day of class.

### **Fees & Important Info:**

1) Course Fee is \$500.00

2) A Non-Refundable Deposit of \$100.00 must be paid to register for class. The balance must be paid in full by the first day of class.

3) Additional Student Drive Fee is \$60.00

4) Refunds: A processing fee of \$50.00 is charged if refund is requested.

5) No Refunds of Fees after the third day of Classroom

6) A \$50.00 fee will be charged if a student does not show up for a scheduled drive without at least 24 business hour notice or does not bring a valid learner's permit for a drive.

7) A \$25.00 fee is charged for returned checks. A monthly invoice billing fee and/or collection fee may be assessed when tuition/fees are not paid in full by the last day of class.

8) Students may miss a maximum of 3 class days, missed class days must be made up. If a student misses a 4th class day, they will be dropped from the course and a course retake fee will be required.

9) Students can be dismissed without refund from the course, for failing to complete 3 drives by the last day of class, or not rescheduling missed classes within one week of absences.

10) A Course Retake Fee of \$250.00 will be charged to repeat the course.

11) Completion of this Traffic Safety Course does not guarantee student(s) will pass the Knowledge and/or Skills Testing for Washington State Drivers Licensing.

### **Course Information**

Parent Night: The first hour of Lesson #1 is good for parents to attend with student. It will go over course information, expectations, and instructions for scheduling drives. All these items are good for both parents and student information. Students are expected to participate in all 15 lessons. Any absences, (maximum 3), must be made up by attending the specific lesson missed.

Student tardiness is viewed as an absence and the entire lesson needs to be made up.

Washington State requires our course to include information about the Organ Donor Program. This portion of the course is optional.

Students are fully accountable for their conduct. Students can be dismissed from the course for misbehavior, cheating (whether sharing or receiving answers), excessive tardiness, misuse, or abuse of equipment, repeated or willful violation of traffic laws, being under the influence of drugs or alcohol, failure to complete assigned work and multiple failed tests during the course. No refunds will be given.

It is 911 Driving School practice to try to have two students in the instructional vehicle. There are instances when this is not possible. By enrolling in a 911 Driving School Traffic Safety Education Course; Parent/Guardian gives 911 Driving School, permission to conduct Behind the Wheel training in a one-on-one setting.

Most instructional vehicles are equipped with video cameras for safety and training. Images from the cameras will never be used for public display of any type. Videos may be retained for up to 5 days unless the instructor fills out an accident/incident report. Videos are the sole property of Wenatchee 911 Driving school and will not be released to anyone other than Law Enforcement in their official duties and Wenatchee 911 Driving School employees. By signing this form, you give Wenatchee 911 Driving School permission to videotape any classroom sessions, lobby activity and drives in our vehicles.

A Traffic Safety Education Notice of Completion will be electronically submitted to the Department of Licensing upon successful completion of all tests and activities required for our program and upon full payment of tuition and fees.

A student signature is needed on attendance records for Department of Licensing verification that all requirements were met.

Prolonging classroom/BTW/Test completion beyond 6 Months from the first day of their class disqualifies students from completing their Driver's Education Course.

**Parent involvement is critical for the student's success!**

50 hours of supervised driving (10 of which being nighttime hours) are required by WA state prior to receiving a driver's license.

If parents refuse to practice with the student and the student is unable to complete the tasks of each Behind The Wheel lesson, parents will need to pay for additional drives for the student to move onto the next drive lesson. This can be avoided by daily practicing at home.

## Intermediate Driver License Restrictions and Penalties

If you are under the age of 18 you must follow these laws after getting your basic license. Driving with Passengers ◦ First 6 months: No passengers under 20 years old, except for immediate family members (spouse, child, stepchild, or siblings, both by birth and marriage). ◦

Next 6 months: No more than 3 passengers under 20 years old who are not members of your immediate family.

### Night-time driving:

For the first 12 months, you cannot drive between 1 a.m. and 5 a.m. unless you are with a licensed driver 25 years or older. The only exceptions are driving for agricultural purposes and transporting farm products or supplies under the direction of a farmer as described in RCW 46.20.070 ([leg.wa.gov](http://leg.wa.gov)).

No cell phones! You are not permitted to use wireless devices while driving, even with a hands-free device. This includes talking on cell phones and sending or receiving text messages. You may only use a wireless device to report an emergency.

### Penalties for violations and accidents •

**First violation:** Passenger and nighttime restrictions will apply until you are 18.

We will send a warning letter to you and your parent/guardian for the following: ◦

Get a ticket for violating the IDL restrictions. ◦

Get a ticket for violating a Rule of the road. ◦

Are involved in an accident where: ■

You get a ticket or are determined to have caused the accident. ■

No one involved in the accident receives a ticket. ■

The cause of the accident cannot be determined.

Only your car was involved in the accident.

**2nd violation:** License suspended for 6 months (or until you are 18, whichever comes first). We will notify you and your parent/guardian before we take any suspension action. •

### 3rd violation:

License suspended until you are 18. We will notify you and your parent/guardian before we take any suspension action.
