

**Driving School Policies** 

I agree to complete the course I have registered for at the current fee. This course consists of eight hours of classroom instruction and a varied amount of behind-the-wheel instruction by 911 Driving School depending on which package is purchased. If Additional behind-the-wheel instruction is required by student/parent, it may be purchased at an additional cost.

The student's successful completion of the above course requires each of the following:

- Reasonable attentiveness and participation in class activities and is not under the influence of any drugs or alcohol. If the student shows up under the influence of drugs or alcohol, the scheduled drive or test will be **forfeited** and a "No Show" fee of \$45.00 will apply. The student will not be able to schedule another BTW lesson or Road Test appointment until all fees are paid in full.
- Appropriate attire that is not immodest or revealing and that does not interfere with or distract from the training process. Although the responsibility for the dress and appearance of the student rests with each student and his/her parent(s), students are expected to show pride in themselves and courtesy to those around them by dressing appropriately. Basic dress code requirements include, but are not limited to, the following:
  - Do not wear "flip-flop" type shoes that may get caught in the vehicle pedals.
  - The hem of shorts/skirts must come to the student's fingertips when standing with hands at the sides.
  - Shirts may not be revealing and should touch the shorts/skirt/pants.
  - Swimsuits are not to be worn to lessons.

In the event a student is in violation of this dress code, the parent will be notified, and the student will be given the opportunity to correct the issue. If the student is not able to or is unwilling to correct the violation before the scheduled start time of the instruction, the drive will be cancelled and a "No Show" fee of \$45.00 will apply. The student will not be able to reschedule the BTW lesson until all fees are paid in full.

- Completion of all behind-the-wheel drive sessions. (It is the responsibility of the student/parent to schedule all behind-the-wheel drive sessions.)
- Must complete course within 180 days (six months) from class day or a reinstatement fee will be incurred.

- All fees must be paid in full prior to start of 1<sup>st</sup> driving session.
- Student/parent must notify 911 Driving School staff members of any medical condition or specialty needs which may affect the student's training so instructors can be aware. (We request that students do not attend any session of training if they are sick.)

This driver training school <u>will not refund any tuition or part of tuition</u> if the school is ready, willing, and able to fulfill its part of this contract. I understand that if I fail to comply with the terms and conditions of this agreement, I am in breach of contract and the school will not be under any obligation to fulfill the terms of this contract, and may, at its option, terminate this agreement immediately.

It is agreed that an owner, instructor, or employee of this driver training school shall not give the impression directly or implied to a student that upon completion of the course the student will receive a license to operate a motor vehicle. However, immediately upon the student's successful completion of the course as described above the driver training school agrees to provide certification of completion to the student (SCDMV PDLA Form).

## For replacement certificates (SCDMV PDLA Form) a \$15.00 administration fee will apply.

## A \$45.00 fee will be assessed for returned checks.

A charge of \$45.00 will be assessed if a student does not show up for a scheduled drive and has not notified the 911 Driving School administration of a cancellation <u>without first giving a</u> 24 hour notice of said cancellation.

\**Please* NOTE: For an additional fee, 911 Driving School will administer the SC DMV license exam. All school vehicles have automatic transmissions.

This agreement constitutes the contract between 911 Driving School and the parent/student, and no verbal statements will be recognized.
