



911 Driving School of Seminole County Driving Policy

Eligibility:

- Students must be at least 15 years of age before the first lesson.
- Students must have acquired a Learners' Permit before lesson 1.
- Students must have parental/guardian's permission to undertake a course of instruction.

Behind the Wheel:

- Completion of this course of instruction does not guarantee student(s) will pass the Knowledge and/or Skills Testing for Florida State Drivers' Licensing.
- No cell phone use allowed in any instructional vehicle except for genuine emergencies.
- Students are fully accountable for their conduct. Students can be dismissed from lessons for misbehavior, excessive tardiness, misuse or abuse of equipment, repeated or willful violation of traffic laws, and being under the influence of drugs (including medication) or alcohol. No refunds will be given.
- Students must be in possession of eyesight correction where applicable.
- Student tardiness is viewed as an absence and the entire lesson will be deemed as cancelled if the student is more than 15 minutes late. Late cancelation fees apply (\$45).
- By enrolling in a 911 Driving School course of instruction, parents/guardians give 911 Driving School permission to conduct behind the wheel training in a one-on-one setting.
- No food, drink, or gum is allowed in instructional vehicles.
- A Traffic Safety Education Certificate will be produced upon successful completion of all tests and activities required for our program and upon full payment of tuition and fees.
- Parental involvement is critical for every student's success.
 - 50 hours of supervised driving (10 during hours of darkness) are required by FL State prior to receiving a drivers' license.
 - Parents may purchase additional drives. Practice may/will be prescribed in order for the student to move onto the next driving lesson.

Fees and Important Info:

- Any outstanding balances must be cleared prior to enrolling in additional classes/drives.
- A \$45 fee will be charged if a student does not attend a scheduled drive without a minimum 24 hour notice or is not in possession of a valid Learner's Permit at the time of the lesson.
- Students are required to attend all behind the wheel driving lessons in appropriate clothing and footwear. No swim wear or flip-flops are permitted.
- Arrival for a driving lesson without suitable clothing or footwear or not in possession of their Learners' Permit, will result in a cancellation and having to reschedule the drive. A late cancellation fee (\$45) will apply.
- Refunds: A \$35 processing fee is charged for any and all refunds.
- Any intentional damages caused to an instructional car, due to a student's actions or negligence, that results in a repair or cleaning, will be charged to the student/parent/guardian.
- All drives must be completed within 9 months of purchase or drives will be forfeited. No refunds will be given for packages not used within 9 months of purchase.
